

## **BUILDING RESILIENCE IN THE AFTERMATH OF VICTIMIZATION HELPING TRAUMA SURVIVORS TO THRIVE**

Victims of crimes, disasters or other harmful events may likely experience trauma. Whether physical or emotional, trauma can be deeply distressing and disturbing. How one deals with trauma contributes to one's ability to endure in the aftermath of victimization. Volunteers and professionals can maximize their effectiveness by employing practices that help victims to use coping and resilience skills to overcome victimization. This 8-hour interactive training will benefit probation officers, first responders, victim advocates, educators, mental health professionals, law enforcement, child protection advocates, and other professionals that interact with victimized individuals. Attendees will gain a deeper understanding of the following:

- Common ways the brain and body respond to traumatic events;
- Short- and long- term needs of trauma victims;
- Ways to help victims build and sustain coping skills;
- Trauma-informed approaches and interventions; and
- The power of resilience.

She is responsible for initiating trauma informed care into the Pinellas ex-offender Re-Entry Coalition and is a board member for Peace4tarpon working to maintain Tarpon as a trauma informed city.
