

# GANGS AND THE TRANSNATIONAL THREAT INVESTIGATIVE TECHNIQUES

This tuition-free, 16-hour Multijurisdictional Counterdrug Task Force Training course is for the street patrol officer, investigator, or detective who is assigned to a criminal street gang unit or investigation. This course will develop an in-depth working knowledge of the laws regarding criminal street gangs and the origins, trends, methods of operation, criminality, and drug activity of the most commonly encountered criminal street gangs. This understanding will then facilitate a thorough investigation (to include ethics, officer safety, and documentation) to prepare the case for successful prosecution.

## Course topics include:

- Identification and classification of gang members and associates
- Strategies for combating criminal street gangs i.e., suppression and prosecution of gangs
- History of gang alliances and rivalries
- Legislation regarding criminal street gangs
- Transnational gangs/domestic terrorist groups
- Documentation, gang intelligence files, and case file management
- Ethical issues and solutions when dealing with gang members
- Common methods of operation used by gangs
- Reading and analyzing gang communications
- Critical officer safety strategies

Instructor Roberto Hernandez is a Special Agent Supervisor (SAS) with the Florida Department of Law Enforcement (FDLE) assigned to the Orlando Regional Operations Center. As a Special Agent, SAS Hernandez was assigned to the Organized Crime Squad where he investigated criminal gangs and other organized crime groups. Other FDLE assignments have included; mid-level narcotics, intelligence, and protective operations. Prior to joining FDLE, SAS Hernandez was a member of the Orange County Sheriff's Office for nine years, five of which he served in the Gang Enforcement Unit. During his tenure, the Gang Enforcement Unit was selected gang unit of the year by the Florida Gang Investigators Association three out of the five years. SAS Hernandez is also an internationally recognized gang identification and investigation instructor for the Office of the Attorney General of Florida and for St. Petersburg College's Center for Public Safety Innovation (CPSI) and has been an active member of the CPSI instructor team bringing Community Policing training to the Caribbean, Central and South America. Prior to his law enforcement career, SAS Hernandez served in the United States Navy as a communications specialist and the Naval Reserves as a law enforcement officer. SAS Hernandez is a graduate of Columbia College with a BA in Criminal Justice Administration.
